- (VII) The medium of instruction must be English.
- (VIII) The school shall appoint only qualified and wligible staff and must pay the splery and allowances and other benefits to the employees of the school.

  It shall in no way be less than the pay given to corresponding dategories of amployees working in Government schools of the State Government.
- (IX) The school and its record shall be open for inspection by an official of the Board or any person authorised by the Board or the State Education Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
- (X) The rate of tuition and other fees charged shall be commensurate with the facilities provided,
- (XI) The admission to the school shall be open to all without any discrimination on the ground of religion. Caste, or race, place of birth or any of them.
- (XII) Institution shall be affiliated or continue to be affiliated or recommended to affiliate unless the middle section of the school is recognized by the education department of the state except in deser where the syllabus of the middle classes is approved by the Chairman.
- (XIII) No unrecognized class branches shall be run within the premises of the school or outside in the name of school.

The following documents should be accompanied slong with the application for affiliation,

- (%) Request of the applicant for affiliation of the school. (in deplicate)
- (b) Application form in duplicate prescribed by the State Govt/Board of Secondary Education/Council for ISC Examination.
- (c) Documents to prove that the pchool is managed by the Registered Society or Trust and one of the principal purposes of such society or Trust must be educational.
  - (d) Details of governing Body.
- (e) Documents to prove this details of landed property,
- (f) Possession certificate.

(g) Location cortificate.

(h) Site plan and sketch plan of the building.

- (i) Total land and details of buildings now available and proposed to be constructed.
- (j) Cortificate obtained from the Health Officer, regarding the health and sanitary condition of the School.
- (k) Details of equipments and furniture.
  - (I) Details of staff now working with qualification,
  - (m) Documents to prove the finencial stability of the Management to meet the running expense of the Sqhoolto maintain it with reasonable standard of officiency and to pay the salaries of teachers regularly and in time.
    - (n) Agreement of the Manager in stamp paper worth Rs.8/to the effect that the school and its records shall
      be opened for inspection to the inspecting officers
      of the Education. Department or such officers
      authorised by Director of Public instruction to
      enable such officers to assess the standard of
      instruction imposed by the sqid school and the
      management shall-at any time render all facilities and
      assistance to conduct the inspection.
  - Agreement of the Manager that compulsory provident Fund Scheme shall be instituted in the said school within a month from the date of application and pay allowance and other benefit of the employees of the School shall be paid not less than dorresponding categories of employees working in Government Schools of the State.
    - (p) Declaration to the effect that the admission to the School shall be open to all without any discrimination on the ground of religion, caste or race, place of birth or any of them.
    - (q) Declaration to the effect that the Management shall not any time move the Government for conversion of the School into an sided school and no unrecognised classes/ branches shall be run within the premises of the school or outside in this same name of the school.

- The school should be run by the registered acciety or Trust and one of the principal purpose of buch society/Trust must be educational. (Y)
- (II) Bach school must have a properly conscioused governing
- (III) The society or Trust should have dinamain abability. It should have permanent source of income to meet suppring expenses of the school to maintain it at a reasonable standard of efficiency and to pay the saleries of the school and in time.
- The Institution should have minimum sits of \$4/2 tests of land for the starting of school. Permanent research tion/affiliation will be recommended only offer very have fulfilled standard condition regarding street (3 acros of land) and have achieved a general standard both in scademic and developmental phases of land, and have achieved a general standard by should have adequate play ground also.
