Whereas the board of trust meeting held on 28 /12 /2017 has decided to amend the deed of trust as it is found necessary for the proper functioning and carrying out the activities of the Trust, and the managing Trustee Sr. Jancy Maria C.M.C. is authorised to execute the deed of amendments,

And Whereas the Provincial Council of the Amala Province of the congregation of the mother of Carmel, the settlers of the trust, as its meeting held on 28 /12 /2017 have approved the above decisions of the trust and consented for the amendments and authorised Sr. Jancy Maria C.M.C. to register the deed of amendments of the trust deed.

1. The Existing Clause- 2 of the Trust Deed is,

The Registered Office of the Trust shall be at Podimattam, Koovappally Village, Kanjirapally Taluk, in Kottayam District, Kerala State. The settlers are at liberty to change the Registered Office to any other place.

Is amended as

The Registered Office of the Trust shall be at Podimattam, Kanjirapally Village, Kanjirapally Taluk, in Kottayam District, Kerala State. The settlers are at liberty to change the Registered Office to any other place.

The area of operation of the trust shall cover all places within the Union of India.

This is purely a service trust and do not intend to conduct any business activities and funds of the trust will not be used for conducting any such activities.

2. The Existing Clause - 4(a) of the Trust Deed is,

To render services in the field of education by establishing, acquiring, managing, administering or otherwise holding educational institutions imparting knowledge in Arts, Science, Commerce, Technical Education, Medical education and other fields of knowledge, from the pre primary

level to the highest available standards, solely for philanthropic purposes and not for purposes of profit and that too irrespective of caste, creed and community.

Is amended as

To render services in the field of education by establishing, acquiring, managing, administering or otherwise holding educational institutions imparting knowledge in Arts, Science, Commerce, Technical Education, Medical education and other fields of knowledge, from the pre primary level to the highest available standards, solely for philanthropic purposes and not for purposes of profit and that too irrespective of caste, creed and community. All educational institutions established and administered by the Arunodaya Educational Cultural and Charitable Trust shall be minority educational institutions covered under Article 30(1) of the Constitution of India primarily for the benefit of Christians. However admissions in these minority educational institutions shall be extended to others as well, irrespective of religion, race, community, caste, creed, colour, sex, language and social status etc;

3. The Existing Clause - 15 of the Trust Deed is,

Bank Accounts: -

The Trust shall open Bank accounts in the name of the Trust or in the name of any of its institutions or activities. The accounts in the name of the Trust shall be operated by the President jointly with the Secretary of the Trust.

Accounts in the name of the institutions / establishments shall be operated jointly by two persons out of whom one shall be the Local manager and the other shall be nominated from time to time by the Board of Trustees.

Is amended as

Bank Accounts:

- a) The Trust shall open Bank accounts in the name of the Trust or in the name of any of its institutions or activities. The accounts in the name of the Trust shall be operated by the President jointly with the Secretary of the Trust.
- b) Accounts in the name of the institutions / establishments shall be operated jointly by two persons out of whom one shall be the Local manager and the other shall be nominated from time to time by the Board of Trustees.
- c) Funds of the trust shall be kept deposited in accordance with the provisions of section 11(5) r.w.s. 13(1)(d) of the Income Tax Act and shall be in bank accounts opened in the name of the trust with scheduled banks/cooperative banks/

nationalized banks and the accounts shall be operated by the President and Secretary/Treasurer jointly.

 d) It is specifically provided that the income and funds of the trust will be solely utilized exclusively for the objectives of the trust and no portion of it will be utilized for payment to the members / office bearers of the trust by way of profit / dividend /interest etc;

4. The Existing Clause – 16 of the Trust Deed is

- a) Any clauses in this Deed may be amended, annulled, added or substituted by the Provincial Council of the Settler, at any time after getting prior approval of the Commissioner of Income Tax
- b) In case there is any doubt or ambiguity regarding any of the provisions of this Deed of Trust, it shall be referred by the Board of Trustees to the Settlers and their direction or decision shall be final.

Is Amended as

Amendments

a. Any clauses in this Deed may be amended, annulled, added or substituted by the Provincial Council of the Settler, at any time after getting prior approval of the Commissioner of Income Tax.

b. This provision of powers for amendment would not be extended to altering the basic character/objectives of the trust and such amendment shall not be repugnant to the provisions of sections 2(15), 11,12,13 and 80G of the Income Tax Act 1961.

c. In case there is any doubt or ambiguity regarding any of the provisions of this Deed of Trust, it shall be referred by the Board of Trustees to the Settlers and their direction or decision shall be final and the trust shall be irrevocable.

The Existing Clause- 17 of the Trust Deed is,

Dissolution

In the event of the Trust becoming impossible to function in accordance with the provisions of the Trust Deed, the Board shall refer the matter to the Settlers and necessary steps may be taken according to its directions of the Settlers.

In case the Settlers decide to wind up the Trust, the excess assets if any, after discharging the liabilities on winding up, shall be transferred to another charitable educational institution of a similar nature as decided by the Board of Trustees and approved by the Settlers and if not it will vest with the Government.
