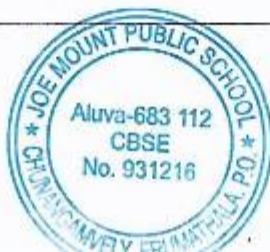
FORMAL PRIOR RECOGNITION LETTER
